ORDER ON ATTORNEY FEES  
AND TAXABLE COSTS

After proper notice to all parties, a hearing on the amount of attorney's was held and concluded on October 27, 2010 in Lakeland, Polk County, Florida. Claimant's entitlement to attorney's fees and costs, for obtaining payment of two weeks of Temporary Partial Disability (TPD), was established in the Final Order filed on July 2, 2007. The Claimant's Verified Petition for Attorney's Fees was filed on June 29, 2010. Claimant is also entitled to an attorney's fee for the obtaining of an MRI of the right shoulder. The following items were marked and considered by me in the resolution of the issues:

1. Claimant's Verified Petition for Attorney's Fees, with three exhibits filed June 29, 2010, as Exhibit 1.
2. The Claimant's Motion to Tax Costs, with four exhibits, filed on July 29, 2010, as Exhibit 2.

3. Employer/Carrier's Response to Claimant's Verified Petition for Attorney Fees filed on July 26, 2010.

Present at the hearing were Attorneys Bradley Smith and Derrick Cox.

A hearing was held in this matter on June 7, 2007 and the claims included entitlement to TPD from May 18, 2005 through the date of the hearing; entitlement to authorization of a psychiatric physician. At that time the claimant withdrew his pending claim for authorization of medical care and treatment for the right shoulder, to include testing. Subsequently at a mediation held on July 16, 2007, the E/C agreed to authorize an orthopedic surgeon for treatment of the right shoulder. As no Petitions for this care were pending at the time of the mediation, it appears that the care was timely authorized and claimant is not entitled to an attorney's fee from the E/C for obtaining this benefit. The claim for authorization of a psychiatrist and for psychiatric care and treatment was denied in the Final Order.

Given the date of loss and the law governing this claim it is appropriate to consider those factors outlined in *Lee Engineering & Construction Co. v. Fellows*, 209 So.2d 454 (Fla. 1968) and *Murray v. Mariner Health*, 994 So.2d 1051 (Fla. 2008) in deciding a reasonable attorney fee amount.

As such in evaluating the claim I considered the following:

**A. The time and labor required, the novelty and difficulty of the questions involved, and the skill requisite to perform the legal service properly.**

Based on my review of the Claimant's time affidavit and the Employer/Carrier's response to the time affidavit, I have determined that the amount of time required by counsel for claimant to litigate this claim was 55.0 hours. Despite Counsel's swearing under oath that all of the hours set forth in the Petition were related to the benefits obtained, it was clear that most of the hours claimed were incurred in the pursuit of claims that were denied. Counsel for the claimant stated at the hearing that the preparation of the Petition was primarily an accounting function. However, the undersigned notes that counsel has sworn under oath that the matters contained within the Petition were true and incurred

in pursuit of the benefits obtained. It is counsel's responsibility to ensure the accuracy of the Verified Petition prior to signing and filing the same. The time listed for legal assistants was generally clerical in nature, duplicated time listed as attorney time or was vague. I have sustained the E/C's objections to this time. Attached to this Order as Exhibit "A" is the time claimed by Counsel for the Claimant with the notations made by the undersigned indicating time allowed.

The issues were not complex and a medium level of skill was necessary to perform this service properly.

**B. The fee customarily charged in the locality for similar legal services:**

I accept from the evidence produced at the hearing that the fee customarily charged in the local area for similar legal services in workers compensation is from \$175 to \$300 per hour. However in determining the appropriate hourly rate to be applied in this matter I have considered not only the experience and skill of the attorneys, but the nature and complexity of the issues litigated. I have determined that based upon the routine nature of the issues involved that the appropriate hourly rate is \$175.00.

**C. The amount involved in the controversy and the benefits resulting to the claimant:**

The benefits secured in this case were two weeks of temporary partial disability and the provision of an MRI of the right shoulder. The amount of the benefits obtained is \$2,787.04. A statutory guideline fee on these benefits is \$557.41. I find the guideline fee to be unreasonable given the nature of this claim and the fact that it required a Final Hearing in order to obtain the TPD benefits for the claimant.

**D. The time limitation imposed by the claimant or the circumstances:**

Claimant's counsel acknowledged in his Verified Petition that neither the claimant nor the circumstances of this case imposed any time limitations on counsel.

**E. The experience reputation and ability of the lawyer or lawyers involved in performing the services.**

The three attorneys primarily involved in the prosecution of this matter were Laurie Thrower Miles, Murette L. Oweis and Bradley G. Smith. These attorneys are knowledgeable and experienced workers compensation practitioners.

**F. The contingency or certainty of a fee:**

The amount of attorney's fees is governed by Section 440.34, Florida Statutes and is contingent.


After review of this matter, including the factors set forth above, I conclude that the reasonable attorney's fee for the obtaining of the above listed benefits is \$9,625.00.

I have reviewed both the Claimant's Motion to Tax Costs and the E/C's objections to the same. Claimant's counsel withdrew the claim for costs that were unrelated to the benefits obtained and acknowledged that the "miscellaneous costs" were not set forth with specificity and thus not taxable. Thus I have determined that the taxable costs due the claimant for the obtaining of the above benefits are \$3,119.60.

WHEREFORE it is ORDERED AND ADJUDGED as follows:

1. The E/C shall pay Claimant's counsel a reasonable attorney's fee of \$9625.00.
2. The E/C shall pay taxable costs of \$3,119.60.
