### FINAL ORDER DISMISSING PETITION FOR BENEFITS

This matter came before me, the undersigned Judge of Compensation Claims, on November 10, 2015 for a Show Cause Hearing. Joseph Kessler, Esquire appeared on behalf of the Employer/Carrier ("E/C"). The Claimant failed to appear.

## PROCEDURAL BACKGROUD

A Petition for Benefits on behalf of the Claimant was filed on 4/17/2015 by Scott Cohen, Esq. Shortly thereafter, Mr. Cohen withdrew as counsel of record effective 5/13/2015. A mediation conference was scheduled for 8/5/2015. The Claimant did not appear to the 8/5/2015 mediation, however, on 8/5/2015 he wrote to the undersigned suggesting that after speaking with Mediator Johnson, everything seemed fine on his case. The E/C appeared to the mediation, and

consequently, the E/C filed a Motion to Enter Order to Show Cause. Due to the circumstances a status conference was scheduled for 9/10/2015.

On 9/10/2015, a Notice of Appearance on behalf of the Claimant was entered by Neil Broderick, Esq. who attended the status conference. E/C's Motion was denied and the mediation conference was rescheduled for 9/30/2015 and re-scheduled for 10/16/2015. On 10/16/2015 both attorneys appeared telephonically to the mediation, but the Claimant was a no show. An Order to Show Cause for Failure to Attend Mediation Conference was entered on 10/16/2015 ordering the Claimant within 10 days to show cause for his non-appearance. Mr. Broderick withdrew as counsel effective 10/19/2015. No response was received from the Claimant and a Show Cause Hearing was scheduled for 11/10/2015. The Claimant failed to appear at the hearing.

# WHEREFORE, IT IS HEREBY ORDERED AND ADJUDGED that:

1. That the Petition for Benefits filed with DOAH on 4/17/2015 is hereby dismissed without prejudice.
