### ABBREVIATED FINAL ORDER AWARDING COSTS AT THE EXPENSE OF THE CLAIMANT

On October 28, 2009, counsel for the Employer/Carrier filed the Employer/Carrier's Verified Motion to Tax Costs. On January 20, 2010, a cost hearing was held before Judge of Compensation Claims Mark H. Hofstad (JCC) in Lakeland, Polk County, Florida. Employer/Carrier was represented by Scott B. Miller, Esquire. The Claimant was represented by Scott F. Eldridge, Esquire. The following are the findings of the JCC:

- 1. Lakeland District is the proper venue and this court has jurisdiction over the parties and the subject matter.
- 2. As the prevailing party, the Employer/Carrier has established entitlement to reimbursement of reasonable costs at the expense of the Claimant.
- 3. The JCC has reviewed the evidence presented at the cost hearing and finds that the costs awarded below are reasonable and within the purview of the applicable statute and relevant case law.
